

#10 Grants and similar amounts: Expenses paid for PTSA sponsored grants to student clubs and school district, scholarships for graduating seniors, volunteer recognition, and membership dues.

#16 Other expenses: Expenses for annual government fees, bacalaureate ceremony, emergency prep supplies, meeting hospitality, leadership training, insurance, and staff appreciation events.
