LOCAL CAPACITY BUILDING. IAF NW continued its core work of building the capacity of local leaders and organizers to improve the welfare of their communities. Those efforts include conducting advanced 6-Day Leadership Institutes for community leaders in the US, Canada and Australia; organizing quarterly multi-day seminars/ training sessions for the professional organizers; and providing weekly phone consultations and on-site mentoring support to organizers and key leaders from the 8 affiliated organizations: Metropolitan Alliance for Common Good (Portland, OR); Spokane Alliance; Sound Alliance (Seattle-Tacoma); North Sound Alliance (WA); Greater Edmonton Alliance (Alberta); Metropolitan Alliance for Common Good-Calgary (Alberta); Metro Vancouver Alliance (British Columbia) and Sydney Alliance (Australia). Highlights of the work by and with the affiliates include the public launching of Sydney Alliance by a very diverse mix of 2,000 people, and developing and teaching a credit course on community organizing practices at the Spokane campus University of Washington School of Medicine.

REGIONAL STRATEGIC INITIATIVES. IAF Northwest focused on two region-wide strategic initiatives during the year-- Green and Equitable Economy Organizing (GEO) and Effective Organizations Through Transformational Leadership. 30 institutional leaders attended the Introductory three-day Transformational Leadership training session and 20 of them returned for the Advanced two-day training. The most significant accomplishment for the Green Economy Organizing initiative was providing capacity building support (6-Day, power analysis, and other leadership training) that helped the Sound and Spokane Alliances team up to deliver key swing votes for a \$1.1 billion statewide capital and environmental infrastructure bill that is creating 20,000 jobs over 3 years. The package included \$15 million in funding that allowed a variety of programs to significantly expand their energy efficiency retrofit work. The IAF Northwest's subsidiary nonprofit-- SustainableWorks-- was able to expand into two new moderate income/working poor communities. It now employs nearly 200 full-time equivalents and is considered one of the most successful examples in the country of the otherwise elusive promise of "green jobs".
