NOVA GUIDES THE SOCIAL AND EMOTIONAL DEVELOPMENT OF EACH STUDENT EMPHASIZING RESPECT, RESPONSIBILITY, AND ACTIVE PARTICIPATION IN A SUPPORTIVE COMMUNITY.

SPECIFICALLY, NOVA PURCHASED 20 LAPTOPS AND A LAPTOP CART TO ALLOW USE OF THE COMPUTERS IN MULTIPLE CLASSROOMS. THESE IMPROVEMENTS REQUIRED ROUTER UPGRADES IN ORDER TO ACCOMMODATE THE INCREASED NUMBER OF NETWORKED DEVICES. WE ALSO REPLACED AGING MONITORS IN OUR COMPUTER LABS WITH NEW FLAT-SCREEN DEVICES, WHICH INCREASED THE FUNCTIONALITY OF THIS WORKSPACE FOR OUR STUDENTS, AND IMPLEMENTED MODERN SOFTWARE UPGRADES. THE IMPROVEMENTS SIGNIFICANTLY INCREASED THE ACCESS TO TECHNOLOGY AND INTERNET LEARNING RESOURCES IN THE CLASSROOMS.
