<b>28</b>	Provide overnight shelter, meals, transportation and other emergency support to homeless families in the Spokane area by partnering with area churches. There are over 600 volunteers who are assential to ensure families obtain services and emergency support. There are 12 churches in the Spokane area rotating space for homeless families. The Organization's network can provide shelter for more than 12 homeless individuals at any given time, for a maximum stay of 30 days. Over 250 families have been served, with a success rate of 77% of families finding permanent or transitional housing. A day center is available for the families during the day, with enrichment classes and resources being available under parent and job training programs. A mentoring program is also under development. Not included in the Form 990 income and expenses are an additional \$41,740 in-kind support and supplies that are passed along directly to homeless families in the community and familes served by the Organization.
