The building is built on land owned by the government and leased to us free on a 30 year lease. We conduct many of our classes from this facility and other, unrelated governmental and non-governmental organizations utilize the facility for their instructional programs as well. We have a paid manager, janitor, and librarians. We also pay for utilities, internet service and repairs.

We contract with government licensed vocational schools to provide this training.
