THESE FUNDS MADE IT POSSIBLE FOR THE BURKE MUSEUM TO DIVERSIFY ITS FINANCIAL SUPPORT AND CONTINUE THE SAME LEVEL OF PROGRAMMING IN THE FACE OF STATE FUNDING CUTS. DURING THE YEAR THE MUSEUM SERVED 103,000 SCHOOLCHILDREN, RECEIVED OVER 111,000 ON-SITE VISITORS AND PROVIDED CURATION RESOURCES FOR 15 MILLION OBJECTS.
