FOUNDED IN 1952, THE SCHOOL ENROLLS APPROXIMATELY 1100 STUDENTS WHO MAKE UP AN ACADEMICALLY, ECONOMICALLY AND CULTURALLY DIVERSE STUDENT BODY. THE SCHOOL IS LOCATED IN WASHINGTON STATE AND OFFERS PROGRAMS IN FOUR (4) LOCATIONS - A JUNIOR-HIGH AND SENIOR HIGH CAMPUS IN CLYDE HILL, ELEMENTARY SCHOOLS IN MEDINA AND WOODINVILLE AND PRESCHOOLS IN WOODINVILLE, MEDINA AND BELLEVUE.
