HOUSING - AT THE CORE OF THE DIRECT SERVICES PROVIDED TO CLIENTS IS NWPP'S ADVOCACY TO PRESERVE AND PROTECT AFFORDABLE HOUSING IN PORTLAND'S DOWNTOWN AREA. NWPP PROVIDES ADVOCACY AND EMERGENCY FINANCIAL SUPPORT TO PREVENT EVICTIONS, EMERGENCY AND TRANSITIONAL HOUSING, ASSISTANCE FINDING PERMANENT AFFORDABLE HOUSING, HOUSING VOUCHERS, AND RELOCATION AND MOVING ASSISTANCE. THIS PROGRAM SERVED 1,636 PEOPLE. EMERGENCY SERVICES - MANY NWPP CLIENTS HAVE EMERGENT NEEDS IN CONNECTION WITH THEIR HOUSING. NWPP'S EMERGENCY FUND ALLOWS STAFF THE DISCRETION TO MEET THESE NEEDS. FREQUENTLY, A RELATIVELY SMALL INVESTMENT TODAY IS ABLE TO PREVENT GREATER PROBLEMS IN THE FUTURE.
