|    | <p>We increased our Voter ID database by an additional 20K, recruited 346 volunteers, surveyed members and analyzed results to be a voice for the health care women need. We held bi-monthly health awareness events and tabled at health fairs to further promote awareness of the importance of participating in health care reform.
