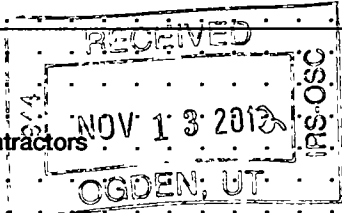

Young Writers Association “maintains a continuous, bona fide program for solicitations of funds from the general public, the community, those involved in the programs, and from government units and other public charities”:

- Donation pleas are in all issues of the free student creative writing journal, *UpStarts*
- Donation pleas are on all registration forms for camps and classes
- Annual donation pleas are mailed out to all participants in YWA programs and to past donors
- Focused donation pleas go out to local businesses to support YWA’s annual literary arts festival for youth
- Focused donation pleas are sent to local bookstores, stationers, art supply stores and eateries to support the annual creative writing contest for gift-certificate prizes and reception food/drink
- A donation plea page (with wish-list and pledge form) is on the YWA website continuously
- The YWA Board Grant Committee researches grants (government units, foundations) that fit and might support YWA’s mission. The grant committee writes approximately five grants a year.

“All other facts and circumstances including sources of support, whether organization has a governing board which represents board interests and whether organization generally provides services directly for benefit of general public on a continuous basis:”

- The silent and extraordinary power of volunteers: Board members, college/university/high school students, parents and professional writers, artists and teachers regularly devote volunteer hours to Young Writers Association-- approximately 12,000 hours annually
- The governing Board of Directors meets monthly from September through June to make decisions, give committee/project reports and divide tasks for furthering YWA’s mission, which is also the board’s mission.
- Young Writers Association “generally provides services directly for benefit of general public on a continuous basis” through its

1.) Volunteer, donation and grant supported, creative writing journal of Lane County youth sent to all schools, libraries and YWA participants (4,000 per printing) in Lane County, three times a year. Free.

2.) Also Poetry Posters by Lane County youth sent to all schools (130 schools) in Lane County and completely supported by volunteers and in-kind paper donations.

3.) Annual Creative Writing Contest is free to the public. YWA receives approximately 300 submissions to this annual contest. Volunteer, professional writers judge the work, while in-kind and monetary donations from individuals and businesses cover both the awards and the food/drink for the winners’ reception.

4.) Annual literary Festival, *GLITTERARY WORD FESTIVAL* is free to the public because of intense volunteer effort from YWA Board Members, as well as grants and individual/business donations. Approximately 500 community members participate.

5.) YWA puts Lane County youth on the radio monthly to read their original work. Their voices go out to over 80, 000 listeners. This free service project has been completely volunteer-powered since its inception in 1995.

6.) YWA hosts youth reading original work in local bookstores and other community venues. Free. Usually 100 attend.

7.) YWA also offers fee-based literary arts enrichment through out the year:

A) After school writing workshops where interested school-aged youth meet with a professional writer weekly through out the school year. Through these ongoing small group “mentorships”, YWA works with about 150 youth annually.

B) For those days during the school week, when school is not in session, YWA offers literature-based, one-day camps for about 250 local students annually.

C) In the summer YWA provides four literature-based weeklong day camps to school-aged youth. Over 100 participate each summer.

D.) Schools through their grants or parent donations typically hire YWA for in-school writing workshops and literature-based programs. YWA probably works with 500 students in the public school setting during one school year.
