LEADERSHIP DEVELOPMENT & LOCAL GROUP CAPACITY BUILDING. Rural Oregon saw a burst of civic engagement and activism this year as small towns used local organizing to build community consensus around and advocate for a fair economy. Organizers worked with new & existing leaders to establish long term action plans, sustainable leadership structures & on-going organizing infrastructure. In total, ROP Organizers logged 8800 miles traveling the state meeting with leaders in their communities. We worked with 22 leadership teams in 14 counties and identified and built relationships with new leaders in another 18 communities. We held 28 community action planning strategy sessions and worked closely with 5 human dignity groups to develop long term organizing strategies. Overall ROP worked with 65 groups representing 29 of Oregon's 36 counties to build local capacity to advocate for human dignity and democracy. In May, we convened over 150 people from every corner of the state for the Rural Caucus & Strategy Session. Rural occupy activists, immigrant leaders, human dignity activists & farmworkers developed organizing strategies, shared skills and built connections across issues & communities. Our 2nd Annual Rural Latino Retreat in March brought together 50 leaders from a dozen counties to identify organizing priorities & capacity building strategies for next year. This work focuses on supporting local groups to foster civic participation, build welcoming communities & advocate for a just economy.

ECONOMIC JUSTICE. Rural and small-town Oregonians held Occupy actions in over 30 communities, holding marches, roundtable discussions, teach-ins, and bold actions in their communities, engaging the 99% of small-town Oregon around the kind of democracy and economy we need in rural America. Rural leaders organized for economic justice on their home fronts and came together statewide for shared action. Locally, member groups' strategies ranged from passing resolutions to overturn corporate personhood, to challenging privatization of schools, to developing alternatives for feeding and housing the homeless. Overall hundreds of activists engaged in local economic justice organizing activities that impacted thousands across rural Oregon. On Dec 19, 2011, the busiest day of the year for post offices, 23 communities— some of the smallest in Oregon— held friendly Occupations at their Post Offices to rally against their impending closure. A month later, the 1800+ petition signatures that we collected from across the state were hand delivered to every Oregon federal legislator. ROP brought these different local strategies together when we convened representatives of over 25 rural Occupations at our Occupy Rural Oregon Breakfast. Participants shared innovative ideas for building alternative community infrastructure and developed next steps to move economic justice forward in rural Oregon.

WELCOMING COMMUNITIES. As Oregon's demographics shift, so does the work of Human Dignity Groups to support our communities in embracing these changes. ROP continued to organize for Welcoming Communities across rural Oregon. From July 2011- June 2012, we held 32 events promoting a safe and welcoming approach to immigration, reaching over 900 people. Overall ROP worked with 10 of Oregon's 36 counties to hold Welcoming activities. We worked with groups to host events looking into race and immigration, community safety, local stories of immigration, and citizenship classes. In many cases, community leaders like sheriffs, county commissioners, and faith leaders were tapped, and all groups are supported to work on cross-cultural relationship building at the local level. Of the groups who hosted events, we worked closely with 7 to hold multiple Welcoming activities to build into a larger campaign. Our "Know Your Rights Tour" visited 10 communities to lessen fear through education on "your rights and the police". In addition, our approach to Welcoming Communities involved engaging rural leaders in a strategy for marriage equality for the LGBTQ community. ROP offered direct support to eight communities from Grants Pass to La Grande to engage in the strategy to build support for marriage equality in Oregon.

collaboration with groups that share our values and support for small-town communities to have

their voices heard. This year we held 2 forums where citizens set the direction of the

conversation. In October, ROP hosted "Voices of Rural Oregon: A Kitchen Table Conversation", a

District 1 Candidate Forum. 150 people representing every county in the district listened as

candidates and constituents sat side-by-side and discussed the issues that constituents face.

In August 2011, Central Oregon hosted a District 2 Town Hall on jobs and the economy. Over 50

people-- family farmers, immigrant allies, union members, peace activists, veterans and

students-- discussed what our communities face in this economy and what we need from our

Members of Congress. As a follow up in Dec. 5 communities simultaneously held actions and

rallies in Congressional District 2 calling upon Congressman Walden to represent Main Street,

not the interests of Wall Street, and to set up regular meetings with his constituents.
