The mission of the Good Shepherd Community Health Foundation is to enhance the quality of life and general health of residents living in the West Umatilla and Morrow County communities Resources are provided to worthy projects best illustrating foundation ideals and fulfilling the health needs of our designated region 2012 marks the seventeenth anniversary of the Good Shepherd Community Health Foundation which at fiscal year end had an asset balance of \$3,080,106 The Good Shepherd Community Health Foundation uses judiciously the interest off of our endowments and donations received from direct appeal campaigns and fundraisers, such as our Scramble for Scholarships Golf tournament and special events, to fund projects in keeping with our mission In December 2011 we partnered with the Hermiston morning Kiwanis club and sponsored the Festival of Trees raising \$14,000 for the foundation in this annual fundraiser In June 2012 we held our 18th annual Scramble for Scholarships golf tournament and raised over \$14,000 specifically to fund people in the community seeking health care careers In May 2012 the foundation awarded \$12,248 in scholarship funds to fifteen students Two \$1,500 scholarships and three \$1,000 scholarships to current GSHCS employees seeking Nursing degrees, \$1,500 to a Loma Linda University Physical Therapy student, \$1,500 to an Eastern Oregon University BSN student, \$1,000 to a BMCC nursing student, \$1,000 to an OHSU dentistry student, and \$500 to an OIT Dental Assistant student We also were able to award five local high school senior scholarships towards pursuit of health careers in dental hygiene, nursing and pre-pharmacy Foundation grants are awarded twice a year, in October and April Grants totaling \$89,079 25 were awarded this fiscal year as follows \$35,200 in grants were made to five designated charities including Eastern Oregon University, Blue Mountain Community College, Vange John Memorial Hospice, Domestic Violence Service West End Project, and Humane Society of Eastern Oregon from the interest on a bequest from Mary Ellen Paul Other grants made by the Health Foundation this fiscal year include \$7,500 awarded to the Coalition Family Health & Fitness to assist with costs associated with hosting the 3rd annual Family Health and Fitness day on September 23, 2011 \$5,000 grant to Guardian Care Center for funding child abuse assessments \$2,000 awarded to the Morrow County backpack weekend food program \$3,362 was awarded to Domestic Violence Services to Purchase appliances for their shelter \$1,789 was awarded to Blue Mountain Community College to purchase equipment for the new wellness center \$3,000 was awarded to CAPECO Community Services to help fund non-narcotic prescriptions \$1,900 was awarded to Hermiston Fire & Emergency for the purchase of a Safety Mobile Unit \$1,945 was awarded to GS Healthy Community Coalition for the Senior health fair \$3,000 was awarded to GS Diabetes Education department for community diabetes education program \$1,500 was awarded to Umatilla Morrow Head Start for purchase of car seats \$1,000 was award to Stanfield Food Basket for funding food needs \$500 was awarded to the Hermiston Public Library for materials for autistic patrons In December 2011, the Foundation again sponsored the "Community Christmas Spirit Award" This award solicited nominations from the community of individuals who represent the Spirit of Christmas, the spirit of giving throughout the year Selected as the 2011 award winners were Sallie Clemons and Terrell Tovey
