The program was first formed in 1993 in Southern Oregon. Now as a statewide program, it runs through the high schools as a winter/spring sport with three main competitions, two of which the athlete must compete in to qualify for the state championship competition. Those qualified in their district are then eligible to compete in a state championship meet against all district winners. Athletic or activity letters may be awarded participants meeting the lettering requirements.

High school equestrian athletes pay fees to compete and stall fees for their horses, all of which cover the costs associated with the competitions. Equestrian athletes and their teams work together to develop team relationships which assist in the team competitions. Associated
