Outpatient Counseling Services - Napa and Solano Counties:

Aldea's Outpatient Counseling Program provides an array of therapies, interventions, and support services to children and families who are struggling with behavioral and emotional difficulties, and mental illness. The program's priority is to assist, support, and strengthen our community's children and families. Services to 1,258 clients were provided at clinic sites, school sites and homes of clients.

4b (Code) (Expenses \$ 1,419,836. including grants of \$) (Revenue \$ 1,229,004.)
Treatment Foster Care - Napa, Solano, and Contra Costa Counties:

Aldea has provided premier Treatment Foster Care services to children ages 0 to 19 since 1985. Treatment Foster Care serves vulnerable children who are removed from their birth homes due to severe abuse, neglect, or emotional disturbance. Masters level therapists staff work intensively with the foster parents in order to provide a safe nurturing home where children can begin to heal from their wounds of abuse. Aldea also provides intensive treatment foster care services for children who would otherwise be institutionalized due to their significant needs. Some of the services include: screening, training, and certification of foster parents; individual and family therapy;

4c (Code) (Expenses \$ 988,538. including grants of \$) (Revenue \$ 969,403.)
Supported Living Services (SLS) - Napa County:

SLS provides support to developmentally disabled adults so that they may live safely in decent and secure homes of their own choosing. This program works at the direction of the person receiving services to increase community independence and to build supports that will ensure the desired quality of life. Aldea served 48 SLS clients this year.
