During FY 2011/12, Children's Council's Subsidy Payments department provided on average child care subsidies for 3,246 children each month, allowing eligible parents to defray all or part of their child care costs The department also enrolled 1,266 children in subsidized care programs through the San Francisco Child Care Connection (SF3C), San Francisco's centralized list of families applying for childcare subsidies Resource and Referral Program offers free child care referrals and community resource information in English, Spanish, Chinese, Russian, or Vietnamese During FY 2011/12 the programs received 6,647 requests for referrals and provided technical assistance to 5,370 families
