Family and Parent Services: 4Cs provides access to and administration of several government sponsored, subsidized child care programs. These programs help low income families who are working, parents seeking work, those who are in training, homeless, incapacitated, or as referred by child protective service agencies. 4Cs was able to assist approximately 700 families during the year, helping approximately 1,250 children with child care services. 4Cs spends well over 80% of program money to pay the actual child care services. Without 4Cs programs, the parents would have to quit jobs, quit school, or have one parent work multiple shifts to make sure their children have the appropriate care during the day.
