responds to more than 1,300 requests for help each year. Staff and volunteers are on call to
provide support on a 24/7 basis. The Sexual Assault Response Team provides leadership to a
multidisciplinary team of responders - collaborating with a pool of specially trained,
on-call, sexual assault nurse examiners who respond to the immediate medical needs of
victims.

Children's Interview Center is a safe place where children are brought by law enforcement for
a forensic interview in order to determine if they victims of sexual abuse. The center is a
