

The Family Intervention Unit responded to more than 3,529 police reports, and provided crisis intervention and case management to 1,788 clients, the majority of these clients resided in Oakland. FVLC's Mobile Response Team served 709 domestic violence survivors in Alameda County by providing 24 hour crisis counseling, safety planning, temporary hotel relocation, transportation, advocacy and other services. FVLC utilized the Client Assistance Fund providing immediate assistance to 37 clients leaving abusive relationships by providing rental assistance, hotel stays, emergency transportation, food and assistance with billings (including utility and medical). This fund remains a lifeline for many survivors who are struggling with self-sufficiency after experiencing abuse.

FVLC's Legal Department is recognized throughout the community as the leader in providing top quality legal services to people fleeing domestic violence. This year, FVLC provided legal information, assessments, paperwork preparation assistance, advice and council and representation to 719 legal clients. FVLC helped 334 of those clients' get 572 court orders.

The Youth Department reached more than 245 youth (middle and high school students) through education on teen dating violence prevention in schools, at community events and health fairs. We produced a movie in collaboration with Youth Radio and presented it and an accompanying discussion guide to 64 teen influencers, spoke at several conferences and presented to community groups, reaching 135 service providers. FVLC facilitated the presentation of Safe Dates, a teen dating violence curriculum, to 121 students from 4 Oakland middle schools and organized a workshop in Spanish and English for 13 parents/caregivers. Our youth leaders also presented workshops on healthy relationships to 54 middle school students and participated in a flash mob in San Francisco's Union Square on healthy relationships which received significant press coverage.

Family Violence Law Center (FVLC) seeks to end family violence in Alameda County by providing support and advocacy for survivors of domestic violence, changing individual and community perceptions about relationship abuse, and advocating for change within the legal, health, education, and criminal justice systems.

Form 990, Part III, Line 4d - Other Program Services Description

FVLC's HEAL program provided 530 clinical hours of mental health services to 23 children and their primary caregivers to help heal from trauma experienced in domestic violence. By providing intensive parent/child psychotherapy to young children who have been exposed to domestic violence, the HEAL Program helps these children overcome the trauma of that experience so that they can go on to have a healthy, normal development.

FVLC actively participated in systems change work. FVLC participated in the development of statewide policies addressing domestic violence with the California Partnership to End Domestic Violence. FVLC trained domestic violence advocates on new laws during the Partnership's annual conference, and helped develop a statewide survey of domestic violence providers regarding the implementation of family law in their communities. FVLC also participated in a statewide leadership group on domestic violence and child welfare and served on an advisory group writing a report summarizing a series of hearings on California's civil justice crisis. Locally, FVLC worked to improve the administration of family law in Alameda County through a series of meetings with the presiding judge of the family law department and court administrators. Additionally, FVLC staff chaired the county's domestic violence service providers' committee and the county's committee of legal services providers.
