



North County Women's Center. Provides a 14 bed, 2-year intensive living skills program for women with permanent and disabling mental health issues; provides an 11 beds, short-term (6month) independent housing, and functions as an intake HUB, providing homeless and chronically homeless women with a wide range of resources, services and links to programs in other agencies. Also, provides safe, clean, short-term residential housing, meals, laundry, and shower facilities to 32 women (and their children) nightly. Clients receive individualized case management, housing case management, access to employment counseling and life skills training.

4b (Code) (Expenses \$ 538,423 including grants of \$ 0) (Revenue \$ 30,604)

Multi-Service Center: Provides short-term and long-term housing case management, housing placement services and housing retention services for low income and homeless men and women. Coordinates client referrals to Winter Shelters. Provides Representative Payee Services (money management); and phone and mail service to homeless individuals who do not have a permanent address or phone and are receiving case management services. Performs outreach and referrals at Quarter Meal Community Meal Service. Services also include assisting clients with eligibility and access to financial assistance funds from other agencies.

4c (Code) (Expenses \$ 575,272 including grants of \$ 0) (Revenue \$ 0)

Men's Housing Program. Provides safe clean, Transitional/Short-term housing, meals, clothing, laundry, and shower facilities to 53 adult men nightly, including transitional housing services to 12 veterans. Clients receive individualized case management, housing case management, access to employment counseling and life skills training. Staff also coordinate client referrals to Men's and Women's Shelter.
