2011–2012 ANNUAL REPORT FINANCES SUMMARY

In the 2011–2012 school year, the Berkeley High School Development Group received and processed over \$600,000 of donations and other revenues, and expended \$470,000 toward Berkeley High and its programs. BHSDG received over \$241,000 in donations not designated for specific purposes. From these unrestricted revenues, BHSDG provided over \$155,000 of new funding for academic, athletic, artistic and club support for school programs. BHSDG's fundraising and administrative expenses were \$38,000 for the school year. We carried forward \$25,000 as a reserve for future needs, and carried a balance of \$25,000 for the fall to pay for the After School Tutoring program for 2012–2013, as well as \$35,000 for Classroom Needs grants. We also began the 2012–2013 school year by granting discretionary funds, in excess of \$5,000, to various departments and support staff for supplies. BHSDG also received approximately \$366,000 in donations and other revenue earmarked for specific programs and departments, the spending of which is determined by these programs and departments. BHSDG administers these funds at no cost as a service to BHS. Berkeley High departments and programs spent approximately \$274,000 of their earmarked funds on a wide range of equipment and educational enrichment opportunities.
