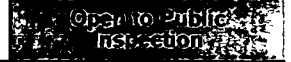

Sisters on the Rise Initiative is a new initiative that seeks to provide a continuum of care and education for the young women who need it the most, by initiating an unprecedented coordination of service providers, advocates and public systems in San Francisco. Sisters on the Rise Initiative is positioned to enact lasting change in the ability of the school and court systems to serve youth of San Francisco by creating infrastructure that centers the voices and experiences of the young women these systems are currently failing.

The Center for Young Women's Development's mission is to empower and inspire young women who have been involved with the juvenile justice system and/or underground street economy to create positive change in their lives and communities. We have been working diligently to address the need of system-involved young women for 19 years. Since our inception we have provide well paid meaning full employment to over 300 young women and helped them to gain the vital skills necessary to increase the opportunities to a livable wage in their future. The American criminal and juvenile justice systems are broken with very little capability to give young women a chance to rebuild their lives, and interrupt the cycles of violence they have experienced to provide a different future for their children and families. The most recent data shows that since mandatory-sentencing laws went into effect in the mid 1980's, the California female prison population has skyrocketed. At the end of 1986, women in California's prisons totaled 3,564. In 1998, the population numbered 10,897-an increase of 305% in twelve years (Source: CDCR). California is home to the world's largest women's prison, the Central California Women's Facility in Chowchilla. Yet as of December 31, 2005, 65.7% of women in California prisons were imprisoned for non-violent offenses, the majority of which were drug-related (source: CDCR). With

71% of women in California prisons report experiencing continual physical abuse by guards or other prisoners according to Human Rights Watch—most of the young women who are trying to rebuild their lives facing staggering barriers. As these young women return, the economic downturn is forcing states and local governments to make even deeper cuts to services and support. Roughly three-fourths of the 9,500 women in California's prisons are mothers—many of them are single parents. Since October 1, 2011 the state has started to deliver on a mandate from the U.S. Supreme Court to remove 33,000 people from its bloated prison population. In this fast and furious process called realignment, it is easy to forget the impact this entire process is having on families, especially women with children. Since 1991, the number of children with a mother in prison has increased by more than 131 percent. These young women need our support more than ever. This year we have realigned our services to best meet the needs of the young women we advocate for, empower and support. We have increased the case management services to provide intensive case management and conducted 32 psychosocial assessments with young women reentering the community post incarceration.

bonding and building community. There was an entire section dedicated to informing young families about policy actions that would affect them and how they could support and get involved with community organizations leading those efforts. There were jumpers, age appropriate games like relay races and musical chairs that adults and kids played together, arts and crafts booths, family photo booths, and wellness tents with free massages, free lunch and giveaway's. We had a sign in sheet at the event and 110 people signed in, 60 of the 110 people said they were pregnant or parenting, and all 110 received a free lunch.

We have enhanced the visiting experience for the entire family; young parents and youth who have small siblings.
