College Track is an educational nonprofit working to increase high school graduation, college eligibility and enrollment, and college graduation rates among students underrepresented in higher education. College Track's intended impact is to close the achievement gap and create college-going cultures by engaging a critical mass of underserved students in College Track programming, partnering with schools and community agencies, and influencing lasting change by raising awareness for college readiness and access initiatives. College Track was founded by two volunteer college counselors who discovered that many students were motivated enough, but lacked the necessary resources to pursue a college degree. These volunteers identified that it was especially difficult for students who would be the first in their families to go to college, as they often had little or no guidance about the college application process at home and many times attended under-resourced public schools that lacked su
