Applicants are awarded scholarships based on financial need. Once an applicant has been awarded a scholarship the school verifies to the BASIC Fund that the student has been accepted and is attending the institution. Scholarship checks are then sent directly to the schools. The institutions are all schools known to the BASIC Fund and we generally have numerous scholarship attendees at each of these inner city schools.
