As an international Christian media network established in 1945, FEBC provides grants to its affiliates which broadcasts in over 84 languages in more than 37 countries and exceeding 781 broadcast hours a day. In 2011 FEBC received over 1.35 million listener responses from Asia, Russia, Africa and the Middle East, which speak of changed lives as a result of listening to our broadcasts.

Christian radio programs are produced in our La Mirada, CA studios in Russian, Mandarin, and Vietnamese languages, which are broadcast via shortwave from the Philippines, as well as AM and FM stations in Russia and Korea. The shortwave Saipan facility shut down in the year with operations shifting to the affiliate shortwave operations in the Philippines.
