Mental Health Services Founded in 1942, Didi Hirsch provides caring outpatient and residential behavioral healthcare services at eleven locations throughout Los Angeles and Orange Counties We serve more than 73,000 children, families, adults, and older adults each year More than 90% of mental health and substance abuse clients live at or below the poverty level Outpatient Services - Didi Hirsch offers individual, family, and group counseling, psychiatric medication management, and case management for adults and children Intensive services are delivered to those experiencing severe mental illness in community, home, and clinic settings On the campuses of 70+ schools, our therapists help students address their emotional and behavioral problems and succeed in their studies We also help ex-offenders who were released under California’s criminal justice realignment (AB109) Clients gain mental and physical wellbeing through participation in peer-led support groups, classes, and recreational activities organized by our Wellness Centers Crisis Residential Care - Didi Hirsch is Los Angeles County’s sole provider of crisis residential treatment, operating two residences, Jump Street and Excelsior House Through a 28-day program, men and women in psychiatric crisis-many of whom are homeless or at risk of it, regain stability and improve their mental health and living situations Specialized Children’s Services - Specialized programs focus on the prevention and treatment of child abuse and on reunification counseling for children who have been found after abduction A specialized program focuses on treating families with young children (0-5) Suicide Prevention - The Suicide Prevention Center (SPC) operates the oldest suicide prevention crisis line in the nation This 24/7 hotline has English- and Spanish-speaking counselors available at all times and takes more than 48,000 calls each year Staff and volunteers provide prevention training at schools, law enforcement agencies, hospitals, counseling centers, places of worship, and community groups Our Suicide Response Team offers immediate support at the scene of suicides through a partnership with the Los Angeles Mayor’s Crisis Response Team For those who have lost a loved one to suicide, SPC provides bereavement support groups and telephone counseling

Substance Abuse ServicesWe offer substance abuse and prevention counseling in our clinics and in the field for people with drug- and alcohol-related problems, including formerly homeless individuals in Los Angeles County’s Housing First program known as Project 50 Community Assessment and Services Center (CASC) - Our CASC assesses mental health and substance abuse needs of people receiving public assistance, connecting them to local treatment providers Women’s Residential Treatment - At Via Avanta, women recover from serious substance abuse in a safe, supportive living environment They attend individual and group counseling sessions, parenting classes, and other activities designed to maintain sobriety and improve employment and life skills Children under the age of six who live with their mothers on site take part in developmentally beneficial activities
