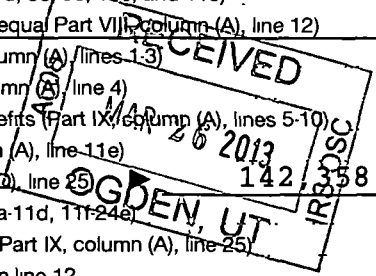

THE DIRECT EMPLOYMENT PROGRAM PROVIDES TRAINING, COUNSELING, AND EMPLOYMENT OPPORTUNITIES TO ADULTS WITH DEVELOPMENTAL DISABILITIES. CLIENTS WORK ON A VARIETY OF JOBS IN A NORMAL WORK ENVIRONMENT SETTING, WHILE EARNING REAL WAGES. THIS PROGRAM OFFERS A WIDE RANGE OF EMPLOYMENT AND VOCATIONAL SERVICES, MAXIMIZING CLIENTS' INDEPENDENCE AND LEVEL OF INTEGRATION INTO THE COMMUNITY. WE PROVIDED SERVICES TO APPROXIMATELY 181 INDIVIDUALS THROUGHOUT THE YEAR WITH AN AVERAGE DAILY ATTENDANCE OF ABOUT 177 CLIENTS.

THE SUPPORTED EMPLOYMENT PROGRAM PROVIDES COMMUNITY BASED EMPLOYMENT OPPORTUNITIES, INCLUDING TRAINING, COUNSELING, JOB PLACEMENT, AND ON SITE JOB COACHING, ENABLING ADULTS WITH DEVELOPMENTAL DISABILITIES TO BECOME MORE SELF SUFFICIENT. THE CENTER SERVES AN AVERAGE OF 76 CLIENTS PER DAY.

WE ALSO PROVIDE OTHER INDIVIDUALIZED EMPLOYMENT PROGRAMS INCLUDING YOUTH INTERNSHIPS, PROJECT SEARCH AND DEPARTMENT OF REHABILITATION DIRECT PLACEMENTS. WE PROVIDED THESE SERVICES FOR 71 CLIENTS THROUGHOUT THE YEAR.
