Early Education: Our early ed programs (California State Preschool and Early Head Start) provide very-low-income parents with high-quality early education services for over 325 children (0-5) each day at our state-of-the-art early education center, through our network of licensed family childcare homes throughout the community, and in individual family homes. WCC recruits highly-qualified teachers, child development specialists and ensures very low staff-to-child ratios. WCC's investment in professional development training and activities provides at-risk children with the rich, stimulating environment they need to succeed in school and beyond. Our programs empower parents to advocate for their children through extensive parent involvement activities and additional support services, classes and resources. For

Child Welfare: WCC has five contracts with LA County Department of Children and Family Services (DCFS): Family Preservation, Family Unity Network, Prevention Initiative Demonstration Project, and Foster Care and Adoption. These child welfare programs protect at-risk children and strengthen families, through in-home and on-site assessments, counseling, case management to over 100 families each month. Our highly-trained staff, many of whom have masters degrees, work with high-risk families to address issues such as violence, substance abuse and depression. When a child's needs cannot be met by the biological family, we recruit, train and support foster parents who provide safe, nurturing homes. In cases when reunification is not in a child's best interest, we find loving, permanent adoptive homes. For this fiscal

Integrated Supplemental Services: Because WCC understands the importance of addressing the needs of the "whole child," involvement in any of our programs connects children and their families to our full array of comprehensive child development and family support services, including access to our full-time public health nurse, healthcare and mental healthcare referrals, screenings (dental, hearing, and special needs), and our full-time disabilities and school readiness coordinators. We link families to many additional services thanks to numerous community partnerships with local universities and other service providers (UCLA, Cal State Northridge, Teach for America, etc.). WCC's holistic approach ensures every child's healthy social-emotional, physical, and cognitive development. For this fiscal
