 SHELTERING AND ADOPTIONS - WE HOUSED 1,732 ANIMALS, WHILE ACHIEVING A 91% SAVE RATE FOR DOGS AND CATS. NO HEALTHY, ADOPTABLE ANIMALS WERE EUTHANIZED, AND THE LEAGUE CONTINUES TO INVEST IN OBEDIENCE TRAINING AND MEDICAL PROGRAMS TO INSURE EVEN MORE ANIMALS ARE REHABILITATED AND ADOPTED. OUR FETCHING FRIENDS TRANSFER PROGRAM GAVE A 'SECOND CHANCE' TO 331 ANIMALS FROM 10 OVERCROWDED SHELTERS IN NEW ENGLAND, GEORGIA, SOUTH CAROLINA, NORTH CAROLINA, PENNSYLVANIA, NEW YORK, TEXAS AND THE VIRGIN ISLANDS. THESE TRANSFERS ARE CAREFULLY COORDINATED TO INSURE NO LOCAL HOMELESS ANIMALS ARE DENIED SERVICE AT THE POTTER LEAGUE. BECAUSE OF THIS TRANSFER PROGRAM, WE ARE ABLE TO GIVE ANIMALS FACING AN UNCERTAIN FUTURE THE PROMISE OF NEW HOMES. WE ALSO WORKED CLOSELY WITH THE RI STATE VETERINARIAN AND THE RSPCA TO (CONTINUED ON SCHEDULE O)
