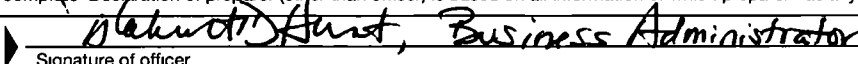

Organization's primary exempt purpose: To advance the life skills of underprivileged and underperforming individuals and families in our community.

Line 28: A major objective of Community Advance is to provide programs that significantly advance the life-skills of students. A life skills mentoring program for Taft Middle School students (6th-- 8th grade) ("The Club") was offered by Community Advance beginning in January 2012. A majority attending this school are Hispanic or Black students, with a significant proportion underperforming in mathematics and reading, from single-parent families, have a high dropout rate, and essentially all are eligible for free or reduced priced lunches. The weekly after-school "Club" sessions include a life skills training topic (presented by invited community leaders), a Biblical focus topic to encourage character and moral values development, and participation in one of the structured elective activities. Student interaction with adult leadership in each of these activities is encouraged by staff and volunteer adult mentors. Planned occasions to interact with the parent(s)/guardian(s) of the students is a priority objective. A total of 64 students enrolled in this first semester session. During the summer school recess, a five-week session was offered with half-day program five days per week. A total of 61 students enrolled. Planning is now underway to expand the Club curriculum offered to encourage students to continue their participation in this program for additional years.
