We operated after school and Saturday school tutorial programs in reading, mathematics, and computer and biological sciences. Approximately 275 students attended tutorial services during the school year. Over 50 tutors/mentors in fields such as education, medicine, engineering, accounting, and computer programming providing these services without pay. In addition to academic tutoring these students are exposed to positive role models. Additionally, 10 persons volunteered in an administrative capacity and 2 persons volunteered as prevention/college coaches.

Telehub - The telehub is a network of community technology centers established in community centers and churches. To date, twelve satellites have been developed to support our core tutorial services. The telehub program has increased access to computer technology/utilization in the inner city of Kansas City, Missouri as a result this program lessens the impact of the digital divide in the Kansas City, Missouri metropolitan community.

The organizations mentoring program has two primary objectives to increase both the mentee and their families knowledge of the dangers of alcohol, tobacco, and other drugs by encouraging protective strategies including teaching healthy beliefs and clear standards, bonding activities, competencies and skills, reinforcement for pro-social involvement and improvement of individual characteristics. To provide mentorship and career counseling on ambition, academic performance, and post secondary opportunities. The college coaching and mentoring curriculum and related activities enable the participants approximately 85 and families to gain valuable information about college attendance, elimination of barriers and identification of financial resources.
