ongoing dance instruction at orphanages and at-risk youth foundations in Panama. Contributions are given to orphanages and at-risk youth foundations in Panama to pay for dance instruction, clothing or competitions needed for the youth throughout the year. These orphanages and foundations provide accounting for all of the contributions and attendance of at-risk youth at each dance class Move-Ex supports throughout the year. Movement Exchange visits all of these orphanages and at-risk youth foundations at least four times a year with international volunteers in order to teach dance to the youth there as well as take classes and exchange choreography with local dancers in Panama- creating an international community of dancers passionate about community service. Move-Ex provides dance education to over 200 at-risk youth in partnership with orphanages and foundations in Panama. 2011-2012 contributions were made to Hogar de la Infancia (orphanage for boys \$325), Malambo Orphanage (orphanage for boys and girls \$1225) Aldea SOS (orphanage for boys and girls \$1000).

Move-Ex volunteers service communities that would otherwise not have access to dance education. Volunteers are exposed to disadvantaged communities and return from the experience with a better understanding of international service work, cultural relativism, and the meaning and need for justice. Many of these volunteers create such strong bonds with communities in Panama that they return frequently to work alongside local volunteers for community advancement. These program costs related to our mission of providing arts education in a cultural exchange setting include:

- Transportation \$10,453
- Food and housing for international volunteers and at-risk youth \$7,790
- Misc. program related expenses (rental of theater, security, guides) \$2,469

2011-2012 was an amazing year for Movement Exchange. We were able to support dance education throughout the year at three orphanages that lacked dance education previously. Movement Exchange worked with local partners in Panama to organize a performance at the National Theater of Panama where over 100 youth performed and the sold out theater included the U.S. Ambassador to Panama and other state employees. Movement Exchange worked with university student dance volunteers from throughout the United States and organized a peer exchange with the dance department of the University of Panama. One university student's experience is expressed here. "There were countless displays throughout the week that legitimized the idea that dance is a vehicle for social change and a powerful mechanism for cultural understanding. I have always believed this, but my experiences this week teaching class in Chepo and Colon, Panama have reminded me and refreshed my passion for dance. I was amazed by the impact we were able to have in such a brief time."
