This category also includes basic classroom supplies requested by teachers for students who cannot afford the needed supplies and supplies for used for special projects. These purchases represent teaching materials that help to enhance the learning experience for students at our schools, but are not possible through district funds.

Playground Equipment - New playground equipment was purchased for the playground at one of our elementary schools.

4c (Code:) (Expenses \$ 12,554 including grants of \$ 0) (Revenue \$ 0)

Student Field Trips - Each year the Austin Public Schools PTC provides funding for student field trips to enhance the learning experience of our students. These field trips are relative to topics the students are studying in school and give them an opportunity that would not be possible without funding from the PTC. The PTC funds transportation and also trip fees for students in need. Field trips taken last year include the Science Museum of Minnesota, JC Hormel Nature Center, Paramount Theater performances, Minnesota History Center, Eagle Bluff Environmental Learning Center, Oxbow Park/Dollman Zoo, Farmer John's Pumpkin Patch, performances at the Ordway and Minneapolis Children's Theater, planetarium, apple orchard, and transportation for elementary students to see performances at the high school and middle school.
