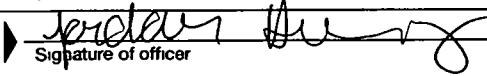

Statement 3

Gamma Phi Beta strives to develop confidence and teach leadership skills to our members. Chapters are led by an executive council of women who organize and manage the overall operation of the chapter including the financial, social and recruitment needs. An extended executive council as well as committees and task forces compliment the work of the executive council, giving any member interested in developing leadership skills the opportunity to do so in a safe and nurturing environment. Much of work done by our members requires not just working with other members of the chapter, but also university officials, local community groups and press, as well as the Gamma Phi Beta sorority international headquarters, alumnae volunteers, and the National Panhellenic Council. The sorority provides training for chapter officers and for our alumnae volunteer advisors. Not only does our sorority offer many leadership opportunities, but many members have transferred their volunteer skills in to jobs and careers. A portion of the sorority leadership development programs are funded by the Gamma Phi Beta Foundation. Some of the opportunities for leadership are collegiate leadership consultants, convention, leadership development institute, regional leadership conferences, and alumnae involvement.
