The organization changed accounting procedures during this fiscal year and, in doing so, incorporated a "resale" account in which members could pay into and then use these funds for novelties, pictures, and other member related personal expenses during the school year. These funds were not included in the previous tax return in the fund balance and the activity in this account was also not reported in previous tax years. The organization incorporated these activities on the 2011 tax return and added the resulting bank account, causing the retained earnings to be higher than on the previous tax return by \$ 20,769. This adjustment ties out to the organization's books and allows the organization to go forward with the correct fund balance.
