Refugee Resettlement

The Refugee Resettlement Program provides case management to newly arrived refugees with the goal of early integration and self-sufficiency. In the past federal fiscal year we resettled 155 ethnic minorities from Burma/Myanmar, Nepalese from Burma, Darfuris (from Sudan), religious minorities from the former Soviet Union, Iraqis and Eritreans. Many of the refugees have lived in camps, have few possessions, and their arrival in our region is their first interaction with complex urban industrial society. We provide case management and extensive cultural orientation.

Immigration Legal Services helps individuals with a broad range of immigration matters focusing on vulnerable immigrants. Two special initiatives: an Immigrant Youth Advocacy Project providing representation to youth in the US without parents or who have been abused and our project on Interpersonal Violence which assists women and other survivors of domestic violence, sexual assault, trafficking or other forms of persecution. During our FY 11-12 fiscal year, this center handled 1600 matters consisting of cases carried over from the previous year and matters opened during the FY 11-12 fiscal year.

Citizenship Assistance focuses on assisting vulnerable adults such as the elderly, and disabled refugees and immigrants who are seeking to naturalize. This program handled 445 cases (a 30% increase from the previous year)

The Asylee Outreach Project (AOP) is a statewide program that assist those granted asylum access by linking them to employment, English language classes. During 2011-12 the AOP provided services to 220 asylees.

Community Education and Advocacy is integrated into all our programmatic areas. We provide training and education on immigration issues to service providers, immigrant community members and the general public. Our staff members are frequent presenters at conferences, synagogues and continuing legal education venues.
