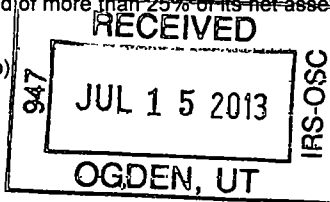

BPA served cohort groups of students ranging in age from k-12 – primarily from underserved communities throughout Philadelphia. Programs took place primarily in out of school time, but some in daytime settings.

Summer Teen Media Collaborative (BPA, Philadelphia Museum of Art, Taller Puertorriqueno and Nueva Esperanza Charter Academy High School) – youth from over 14 schools throughout the city participated in this application/interview-only program that continues to have waiting lists year after year.

In addition, BPA was able to reach new heights bringing industry opportunities to our students throughout our relationship with the Greater Philadelphia Film Office – who referred us to a Chicago-based production company who were filming a low-budget SAG feature film starring Christopher Gorham, Kelly Rutherford and Mario Lopez entitled “The Stream” – producers were looking for youth to help crew on the film and we are proud to have sent 15 of our BPA students to work on a feature film set – we made BPA History with this initiative and hope to continue to provide more industry opportunities to youth for years to come. Their Supervising Producer requested our students to return for one additional week stating “They are making our lives so easy and we enjoy working and collaborating with such experienced and engaged youth.”

BPA continued its production on their documentary GATEWAY, wrapping principal photography is scheduled for the coming year.

BPA’s Executive Director was asked to continue her service on the Philadelphia Cultural Fund review panel. Ms Ryan also served as juror for the Mordechai Ancielewitz Art Exhibition – a Jewish Federation of Philadelphia sponsored annual event for youth to submit works of mixed media commemorating the Holocaust. Ms. Ryan also continued work as a founding member of the Philadelphia Youth Media Collaborative, had a panel speaking engagement at the ACM Conference held in Philadelphia, served as juror for WHYY’s Youth Media Awards.

BPA Student Jessica Grose’s film, Reflections received a special judges prize (First Place) as well as second place overall for the WHYY Youth Media Awards.
