Learning Connections - focuses on preventing severe academic difficulties or school failure by providing intensive reading, writing and math instruction for low-income children and youth, resources for classroom teachers, and support for their parents In FY2012, the Learning Connections program enrolled 499 students, 71% of students improved their academic skills as measured on pre and post-tests Additionally, the Parents as Partners program, which complements the Learning Connections program, aims to increase parental involvement in literacy and served 219 parents and 213 children, 99% of parents gained useful information and strategies to support their children's academic success

Assessment and Instructional Services - includes learning and attention-deficit diagnostic assessments, individual consultations, and individualized tutoring to assist children, youth, and adults in improving their learning strategies and skills to meet their academic, vocational, and personal goals LDA provided individualized and intensive services to 94 assessment and tutoring clients during FY2012, 98% gained self-knowledge and strategies to achieve their goals
