We are committed to reaching out to others throughout the world to help to meet their physical and spiritual needs. 28	During this fiscal year, Touching Lives Worldwide (TLW) has primarily been working in Haiti and the Dominican Republic. The programs and projects that were started in the previous fiscal year, continue to be supported. However, in this fiscal year that ended August 31, 2011, TLW has expanded their services and projects in some of the same communities and added other needy communities to the areas of their operation. In the town of Dajabon, Dominican Republic, they have a mission school for deaf children. Their school provides a great education for children that otherwise have no other options of getting an education. Without their school, those same children would grow up, as other deaf children do, without knowing their name, age, or even how to tell time. Through their special school, they also provide much more than an education for dozens of deprived Haitian and Dominican children. They provide some food, healthcare, clothing, and love and affection. Their mission school also offers other community programs such as English/bible classes (consisting of approximately two hundred children and adults), American Sign Language classes for parents and community adults, and many church activities for everyone. In addition, they support, financially and as volunteers, the Dominican chartered Christian non-profit organization known as GOD IS TOUCHING LIVES IN DOMINICAN REPUBLIC, INC. Through their donations to this non-profit organization, they are helping to support (with food, shelter, clothing, education, healthcare & more) an orphanage, in Quanamithe, Haiti, with 37 orphans. Also, they are helping to provide medical care for many other children, as well as adults, in both Haiti and the Dominican Republic. Among all that this small organization does in Haiti and the Dominican Republic, they also work with numerous people, here in the U S A , helping to make a "real difference" in their lives by providing comfort, encouragement, & advice during times of crisis, or by fulfilling other needs of healthcare, finances, spiritual guidance, or even loneliness.
