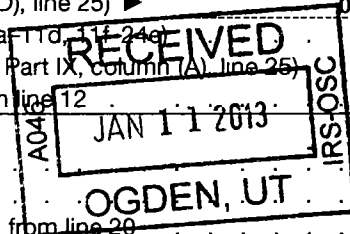

College Enrichment Program
In the late spring of 2012, Southwest Border AHEC collaborated with Southwest Texas Junior College in establishing a summer enrichment program for college students interested in entering the health professions. This was a 56 hour program designed to facilitate the entry of undergraduate students into medical and/or health care professional schools. The curriculum, which consisted of 4 enrichment courses to enhance their academic skills and competitive standing, included critical thinking, science enrichment, study skills and communication skills. A total of 7 community college students enrolled in the program with 95% graduating. Five students were provided with a \$100 stipend, one student with a \$90 stipend, and one student with \$85 stipend. The 4 professors each received a \$600 honorarium. Other expenses included materials, supplies and snacks.

Health Career Summer Camp
In response to its mission in promoting health career activities as a means of recruiting health care professionals, Southwest Border AHEC conducted a health career summer camp for the fourth year in a row for high school students from the Eagle Pass Ind. School District. A total of 22 students enrolled in the one week 32 hour program from June 18-22, 2012. Activities included hands on activities, insights from health care professionals (including physicians, EMTs and nurse practitioners), skills practice and trips to health care facilities. Expenses related to travel to San Antonio to visit the marine animals of Sea World, medical supplies and other training costs. All students completed the program.
Southwest Border AHEC also conducted a one day health career camp in Uvalde, Texas with 6 high school students in attendance. The 6hr camp was conducted at the local Hospital with health care professional as speakers, each demonstrating a skill to the students.

Teen Academy for Health Professions
From January-May 2012, a total of 40 high school students enrolled in this 40 hours academy to teach students not only about health careers but also about anatomy, medical terminology, disaster preparedness and college preparation. The students met every other Saturday for 4 hours learning about medical careers and procedures public health careers, allied health and nursing. A total of 20 students completed the program and attended the graduation ceremony held on May 19, 2012. Many of the parents attended the ceremony.
