Assessment data and evaluations demonstrate that Live It Learn It has a major impact on student achievement (with average scores on written assessments nearly tripling) and motivation (with 95% of students indicating that Live It Learn It's programs inspire them to learn more about academic topics studied with Live It Learn It.)
