During the period of September 1, 2011 to August 31, 2012, the Endowment Fund supported the construction and purchase of medical equipment of the Chincha Medical and Educational Center in Chincha, Peru, which had been devastated by an earthquake in 2008. The Center began treating patients during 2011 but was not self-sufficient and needed funds for the first year of operation. The EF also sponsored
