Creative Writing Education The Loft offers creative writing classes year-round in the classrooms at Open Book, at community sites throughout Minnesota and online In FY12, the Loft served more than 2,600 adults and 900 youth creative writing students in over 300 classes and four conferences representing the broadest range of genres In the past year's evaluation, 94% of adult students reported that their writing improved, 85% reported a greater understanding of the writing craft, 90% agreed that the class helped them identify their next steps as a writer, and 96% would recommend the Loft to others Of our young writers, (age 6-17) 89% said they learned more about creative writing and 95% said they would be better writers in school
