Average annual enrollment is currently maintained at 25 students, with all thestudents on research fellowships. During the year the International Academy of Science hasmaintained a dedicated connection to the Internet and a registered domain name, science.edu,thereby providing Internet access to the faculty and students. The Internet access has been avaluable research tool at the Academy. The International Academy of Science also provides onlinecourseware to public and private schools throughout the country.
