Elementary Program - Consists of Soccer, Writing Summer and Winter programs. Soccer - Poet-Athletes meet with soccer coaches for practices and games during after school hours 3 days per week for 20 weeks of the school year. This curriculum emphasizes character building skill such as leadership, teamwork, and commitment. Writing - Poet-Athletes meet with their writing coaches for creative writing workshops during the after school hours 2 days per week for 20 weeks of the school year. Poet-Athletes then select a community issue and work as a team to implement a service project. Summer and Winter - Poet-Athletes meet and partner with various community organizations to provide health and literacy programming. Programs range from one-day to six week camps, clinics and tournaments.

Middle School Program - Consists of Soccer, Writing Summer and Winter programs. Soccer - Poet-Athletes meet with soccer coaches for practices and games during after school hours 3 days per week for 20 weeks of the school year. This curriculum emphasizes character building skill such as leadership, teamwork, and commitment. Writing - Poet-Athletes meet with their writing coaches for creative writing workshops during the after school hours 2 days per week for 20 weeks of the school year. Poet-Athletes then select a community issue and work as a team to implement a service project.

Summer Camp - DC SCORES hosts three camps over six-weeks in the summer. Two camps are soccer-only for approximately 150 low-income students. The camps are free to the students and families and operate for 5-7 hours/day. Our six-week arts and soccer camp enrolls approximately 40 low-income elementary students in a 6-hour daily combination of arts programming and soccer/health programming. The arts and soccer camp also employs Summer Youth Employment staff, which are typically high school age youth who have been through the DC SCORES program.
