4A. International Ministries

1. Project Ethiopia:

a. PAWE HOSPITAL: Joshua's Way continued its partnership with Beza International Ministries in Ethiopia as it gave aid to the Pawe hospital in the form of medical equipment and in providing funding for the poorest patients to cover their patient cards and treatment.

b. WATER PURIFICATION SYSTEM: Engineering site visits for the installation of a water treatment system to provide potable water to the hospital have been completed. This project has been delayed until governmental approval and permits are obtained from the regional health officials in the Benishangul-Gumuz region of Ethiopia. Joshua's Way is prepared to begin installation of this system within a matter of weeks of receiving the necessary approvals and is diligently seeking to obtain those approvals.

c. SOLAR COOKERS: Joshua's Way has explored ways to promote and facilitate the use of solar cooking in Ethiopia. Solar cookers help reduce deforestation, soil erosion, and the number of hours spent daily collecting firewood. Pulmonary problems from inhalation of smoke from cooking fires can be reduced with the use of a solar cooker. The initial distribution of 100 hundred parabolic solar cookers manufactured for Joshua's Way in Addis Ababa was completed in April 2011. Evaluation of the effectiveness of the solar cookers is ongoing.

2. Cross Culture Network: Cross Culture Network, a ministry of Joshua's Way to international students, provides a variety of services to international students at upstate universities in order to build relationships and share the Gospel with them. Florin Palaghia oversees this ministry. Services provided to students include trips to acquaint them with historical sites in the United States, banquets to introduce them to American friends, a traditional Thanksgiving meal, discussion groups, Bible studies, "friendship partners" for these students while in the U. S., and practical assistance in finding furniture and other goods and services. The ministry to international students includes students from Greenville Technical College and USC Upstate in addition to ICAR students and students at Furman University. 95 international students from more than 20 different countries participated in the Southern Hospitality Banquet in September 2011.

3. Venezuela Mission: Joshua's Way assists the Iglesia Cristiana Evangelica el Buen Pastor in La Puerta, Venezuela. The financial support of Joshua's Way helps this small, evangelical church reach out to its community through the use of AWANA, a program of Biblical instruction and discipleship for children. It also provides funds for medical assistance to some of that church's poorest members. The Iglesia Cristiana Evangelica is the only Protestant, evangelical church in La Puerta.

4B. Teaching/Service Ministry

a. Teaching Ministry - Joshua's Way provides courses and seminars to give lay people a deeper understanding of the Scriptures and Christian faith and to encourage them to actively minister in the community. Virginia Griffin led a series of lessons on Heaven in October and November of 2011. Paul Rogers and Johnny Price shared teaching responsibility for the Stellar Bible Study during the Winter/Spring of 2012.

b. Homeless Ministry - Joshua's Way partners with Nothing But Jesus Ministries to serve the homeless of the Greenville area. In any month that has a 5th Saturday, Joshua's Way provides the meal and presents the Gospel message on that 5th Saturday to anywhere from 50 to 75 homeless people in the downtown area of Greenville. Seacoast Church has come alongside Joshua's Way to assist in the preparation of food for these events. Joshua's Way also collects coats and blankets, and occasionally, toiletries for the homeless.

4C. Operation Christmas Child

Joshua's Way serves as a local collection center in cooperation with Samaritan's Purse for shoeboxes filled with gifts for children in foreign countries around the globe. Many upstate churches, schools, businesses and individuals participate in the preparation of shoebox gifts to carry an evangelistic brochure in the child's language sharing the gospel of Jesus Christ. Joshua's Way collected 12,310 shoeboxes during Operation Christmas Child 2011.
