The Health System Strengthening Area includes PHII (the Public Health Informatics Institute), TEPHINET (Training Programs in Epidemiology and Public Health), African Health Workforce Project, and the Global and Domestic AIDS Program PHII provided direct service to the US public health system through a cooperative agreement with CDC, funding from the de Beaumont and Robert Wood Johnson Foundations, and from HRSA These funds supported the creation of a national disease surveillance system, a cloud-based system, that will become the basis for common data storage for public health practitioners and CDC PHII also provided consultation to Uganda’s Ministry of Health to establish their e-health strategy, a strategy for improving their health system through smart application of information technologies PHII also partnered with national public health associations to redefine how infectious disease surveillance will be carried out as the health care system adopts electronic health record systems Finally, PHII served as secretariat for the Joint Public Health Informatics Taskforce, a collaboration of public health associations that works together to forge common national information interoperability TEPHINET (Training Programs in Epidemiology and Public Health), and the Global and Domestic AIDS Program Created in 1997 as a professional network of field epidemiology training programs, TEPHINET is not only an effective global network of information exchange to more than 57 FETPs, but it also supports a broad range of regional and national projects that strengthen public health capacity During fiscal 2012, TEPHINET launched a pilot accreditation program in Brazil, Zimbabwe and Vietnam, and held 6 regional and worldwide conferences Accomplishments for the African Health Workforce Project during the year included t rained 50 health managers during a pilot testing of a newly designed training package on data driven health workforce planning and management, provided over \$300,000 worth of computer equipment for Kenya’s health professional regulatory boards and councils, established a joint regulatory professionals working group of all boards and councils in Kenya to work collectively and collaboratively to address areas of common interest in a more efficient and cost-effective manner, completed a data system for the Nursing Council of Zimbabwe for managing data on over 8,000 nurses employed by the Zimbabwe Ministry of Health, supported the strengthening of national continuing education programs for nurses and midwives in Malawi, Lesotho, and Swaziland, as well as reviews of the national nursing act in Seychelles and the profile for nurse educators in Mauritius, through regulatory improvement grants, targeted technical assistance, and regional collaborative meetings Global and Domestic AIDS Program Through the Global AIDS programs, The Task Force develops and provides training materials to CDC, to be used for AIDS education This effort is part of CDC’s AIDS prevention activities in developing countries Accomplishments during the year include produced over 5,000 toolkits for use in a national campaign to increase awareness of the dangers of drinking alcohol and transmission of HIV, developed a training package and materials to build capacity among primary health care providers to ensure that all patients receive HIV testing and prevention counseling, developed materials for use by community-based counselors in helping clients understand the risk of HIV and the importance of getting tested

The Neglected Tropical Disease Program includes Children Without Worms (CWW), The International Trachoma Initiative (ITI), the Lymphatic Filariasis Support Center (LFSC), and the Mectizan Donation Program (MDP) CWW partners with Johnson & Johnson (J&J), and GlaxoSmithKline (GSK), and the World Health Organization (WHO) to promote comprehensive control of STH, which includes treatment with albendazole or mebendazole CWW was established in 2005 as a joint partnership between J&J and The Task Force for Global Health In 2007, Cameroon was the first country to receive donated mebendazole In 2010, J&J quadrupled its commitment and pledged to donate up to 200 million doses of mebendazole each year In 2011, CWW partnered with GSK and WHO to support the donation of albendazole for the treatment of STH In 2012, the number of doses of mebendazole approved for donation by J&J more than doubled from the previous year to 102 91 million doses donated to 13 countries GSK quintupled its donation pledged to donate up to 200 million doses of mebendazole from the previous year to 98 26 million doses approved for donation to 28 countries In total, 201 17 million doses of deworming drug have been approved for donation in 2012 to treat school-age children International Trachoma Initiative (ITI) is a partner in the global effort to eliminate blinding trachoma by 2020 That is an ambitious goal, but it is achievable for two reasons (1) ITI promotes the WHO-endorsed SAFE strategy that brings Surgery, Antibiotics, Facial cleanliness and Environmental improvement to the poorest communities in countries where trachoma is most likely to be found, and (2) ITI works hand- in-hand with national governments as well as local and international global health organizations on an integrated approach with other NTDs ITI’s core responsibility is to manage Pfizer’s donation of Zithromax(R), an antibiotic used to treat and prevent trachoma ITI promotes and supports effective partnerships at the global, regional, and country levels to eliminate blinding trachoma ITI also works to generate, integrate, and disseminate knowledge about trachoma to those engaged in the effort to end this devastating disease ITI’s accomplishments for the year include managed the distribution of 45 million Zithromax(R) treatments for the elimination of blinding trachoma in 19 countries, and expanded the distribution of Zithromax(R) treatments to Guinea, Mozambique, and Zambia In addition, ITI received approval to donate Zithromax(R) to two new countries in 2013 - Central African Republic (CAR) and Chad, developed a mobile application for smartphones and tablets to record trachoma mapping data, these data will be published and made available through open access on the ITI-managed Trachoma Atlas at www.trachomaatlas.org, streamlined the Zithromax(R) supply chain by shipping bottles with 500 tablets, which are easier to transport and take up less shelf space than the previous 30-tablet bottles The new, larger bottles cost less to move from central medical stores to remote villages where they are distributed, in collaboration with The Task Force’s Children Without Worms program and Emory University’s Center for Global Safe Water, ITI hired a coordinator for Water, Sanitation, and Hygiene (WASH) This staff member will help foster joint efforts by the WASH and NTD sectors to protect families from trachoma and other NTDs, conducted media and advocacy training workshops for Ministry of Health officials in Uganda, trained journalists about their country’s Master Plan for NTDs, and arranged field visits so journalists could see first-hand and report on the impact of NTDs on the daily lives of Ugandans The Lymphatic Filariasis Support Center (LFSC) is the recipient and coordinator of the Bill & Melinda Gates Foundation grant entitled "Resolving the Critical Challenges Now Facing the Global Programme to Eliminate Lymphatic Filariasis" on behalf of the Global Alliance to Eliminate LF (GAELF) The LFSC provides technical expertise and collaborates closely with partners involved in the global elimination of LF ("elephantiasis"), a principal cause of disability found in 80 countries and territories LF infection is a risk to more than one billion people, primarily in developing countries Accomplishments during the year include continued research to assess elimination of LF transmission by testing more than 15,000 children in 10 countries to evaluate whether MDA succeeded in lowering infection rates below critical levels Results of this research allowed MDA to be stopped in study areas in nine of the ten countries assessed, integrated STH assessments with ongoing LF Transmission Assessment Surveys Because the medicines used to prevent LF also treat soil-transmitted helminths (STH), integration of these assessments helped identify appropriate strategies for STH control after LF treatment is stopped, supported research of new "xenomonitoring" collection strategies, which measure LF infection in vector mosquitoes as a proxy indicator of ongoing transmission in humans, collaborated with RTI and WHO to develop a document "Tool for Integrated Planning and Costing," which allows NTD country programs to plan, budget, and calculate gaps in program funding, led the development of a powerful, user-friendly, Android-based data collection application and support for a web-based data management, mapping, and reporting system called LINKS The application is used to collect relevant health data for tens of thousands of people living in NTD-endemic areas for projects conducted by LFSC and other global health partners

The Center for Vaccine Equity (CVE) are includes Accelerated Measles Mortality Reduction Improving Routine Immunizations in Africa (AMMRIRIA), Coalition for Cholera Prevention and Control, Polio Antivirals Initiative, the Uganda Immunization Training Program and Voices for Vaccines Vaccines remain the most powerful tool for preventing infectious diseases The mission of The Task Force’s Center for Vaccine Equity (CVE) is to assure the equitable use of vaccines everywhere and the eradication of poliovirus The primary activities of CVE are to identify and implement innovative approaches to reduce or eliminate the burden of vaccine-preventable diseases and lead a global partnership to develop poliovirus antivirals for use in the polio eradication effort CVE is developing innovative approaches to assure that vaccines are available wherever they are needed Current activities include working with stakeholders to optimize the use of cholera and rabies vaccines and advocating for development and licensure of vaccines that are not currently being pursued by companies in industrialized countries Additionally, CVE is expnding its role in providing a balanced and fact-based source for information on the safety and effectiveness of vaccines The work being done through the Polio Antivirals Initiative is designed to remove the threat of transmission of poliovirus from patients who are not able to eliminate the virus, and, in this way, contribute to the control of outbreaks as part of the end-game strategy for polio eradication AMMRIRIA’s program accomplishments include collaborated with the Measles Rubella Initiative, the Global Polio Eradication Initiative, the GAVI Alliance, and the Africa Progress Panel to increase commitment of resources to immunization, both routine immunization and supplemental immunization activities, provided technical consultation on vaccines and health policy to senior officials, developed a policy brief on assuring sustainability of immunization programs and other global health initiatives in sub-Saharan Africa The policy brief was used to plan further activities with the Africa Progress Panel, provided support to Mrs. Rosalynn Carter in her outreach to African first ladies, participated in global advocacy planning with the Measles Rubella Initiative and its partners, participated in the Africa Regional Conference on Immunization (ARCI) and the African Regional Inter-Agency Coordinating Committee (ARICC) and provided input on the Global Vaccine Action Plan at a hearing associated with those meetings Over the past four years, PAI and its collaborators have broadened the network of resources and support and made significant progress in bringing forward safe and effective polio antiviral drugs Accomplishments include completed single- and multiple-dose Phase 1 safety and pharmacokinetic studies in the UK with lead polio antiviral, called V-073, produced by ViroDefense Inc , a pharmaceutical company, designed and implemented a first-of-a-kind, proof-of-concept efficacy clinical study with V-073 in Sweden The PAI steering team, a panel of experts, along with ViroDefense, RIVM, and CDC, reviewed the study design to ensure the study would meet the objective of determining the effect of V-073 on shedding of Sabin type 1 vaccine strain of virus in healthy volunteers, identified additional antiviral compounds which work by different mechanisms of action from V-073 The use of two antiviral agents with differing mechanisms is expected to markedly reduce the potential for development of drug resistance in the treatment of immune-deficient persons excreting virus This research is being conducted by CDC, GlaxoSmithKline, and ViroDefense Inc
