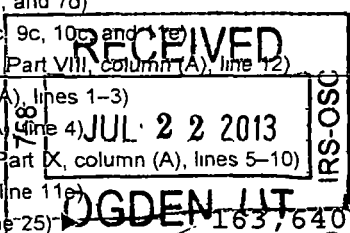

Our vision: to enhance the quality of life through the transformative power of live theatre and to introduce and enable participation to community members who might otherwise not be able to experience it.**

Six shows were produced during the season providing a quality theatrical environment for students and community members to practice their talents, to learn theatre arts, and an opportunity to be involved in local productions and community theatrical enrichment. The six productions were: All My Sons - 38 performances/7,488 attendees; The Effect of Gamma Rays on Man-in-the-Moon Marigolds - 32 performances/6,418 attendees; The Pitmen Painters - 39 performances/7,537 attendees; Master Harold and the Boys - 30 performances/5,505 attendees; Proof - 30 performances/4,150 attendees; The Fantasticks - 24 performances/4,646 attendees.

The Master Playwright Series gave public presentations of lectures and staged readings of three established playwrights. The three playwrights were: Moliere, Lillian Hellman, and Athol Fugard - 18 performances/2,291 attendees. These forums allowed for public comment, discussion and education.

Approximately 10% of our effort is spent on student educational initiatives, including apprenticeship and intern programs for theatre students. Open rehearsals were held for students at no charge and interested students were offered positions to work as apprentices assisting directors, stage managers, light and sound operators, and prop and costume mistresses. Students also had the opportunity to audition and receive guidance from theatre professionals to polish audition techniques, including monologues and song presentations. The culmination of the student educational initiative was the presentation of the EMERGING ARTISTS SHOWCASE in partnership with graduating senior students from the Dreyfoos School of the Arts.
