Grants to the Center for Jewish-Arab Education in Israel helped fund the new "shared communities/integrated schools" initiative. Part-time and full time community outreach workers were hired in cities of Tel Aviv, Haifa and Jerusalem and they worked to recruit parents and families interested in opening new integrated schools. In Tel-Aviv over 150 Jewish and Arab families engaged in joint activities including lecture series, Arabic language courses, inter-faith holiday celebrations, steering committee for new school and more. In Haifa 50 families engaged in similar joint programs and start up work was carried out for the opening of a new integrated Jewish-Arab preschool. (The new school opened in Sept 2012.) In addition, the second high school 12th grade class graduated in June 2012. The first ever national summer teacher training conference for ALL of Hand in Hand staff was held. The Hand in Hand school in Jerusalem hosted an official visit by Israeli Minister of Education, speaker of the Israeli parliament and other members of parliament in December 2011.

In October & November 2011 Lee Gordon toured the US with 2 high school students from the Hand in Hand school in Jerusalem (one Arab and one Jewish). The students made 37 presentations in synagogues, mosques, churches, universities, high schools and private homes. Cities included Los Angeles, San Antonio, Austin, Chicago and New York. Hand in Hand executive director in Israel, Shuli Dichter, visited the US twice and gave lectures at a conference in Washington DC, in several synagogues and at private receptions. Lee Gordon recruited 10 college students to volunteer at Hand in Hand's summer day camp held in July in Jerusalem. New social media including regular communication via facebook was implemented in the US. This has expanded Hand in Hand's audience in the US. Director Lee Gordon gave 35 presentations in cities that included San Francisco, Seattle, Los Angeles, Chicago, New York, Portland and Washington DC, and Wesleyan University.

Grants to the Hagar helped the Hagar integrated school in the city of Beersheba continue to grow its program and increase enrollment.
