FRIENDS OF THE CHILDREN (THE ORGANIZATION) IS A NON-PROFIT ORGANIZATION THAT PROVIDES PORTLAND'S MOST AT-RISK CHILDREN WITH INTENSIVE AND LONG-TERM MENTORS. WE TAKE A PREVENTATIVE, EARLY INTERVENTION APPROACH THAT BREAKS THE CYCLE OF POVERTY AND ABUSE BY HELPING CHILDREN IN NEED TO OVERCOME THE MANY OBSTACLES IN THEIR LIVES. THE CHILDREN IN THE PROGRAM HAVE SIGNIFICANT CHALLENGES WITH 54 PERCENT HAVING PARENTS THAT DID NOT COMPLETE HIGH SCHOOL, 60 PERCENT HAVE ONE OR MORE PARENT THAT HAS BEEN INCARCERATED, OR 60 PERCENT BEING BORN BY A TEEN PARENT.
