During fiscal year 2012, 275 students participated in the Organization's student productions, and more than 10,000 people attended the shows.**4b** (Code: 44-8000) (Expenses \$ 341,691. including grants of \$ 2,945.) (Revenue \$ 401,914.)Summer Programs: Studio East offers a wide range of theater-based summer programs that engage students in the skills and techniques of theater performance. Programs include 1 and 2 week theater camps for children from 4-19 year old at all ability and experience levels, capped by the Organization's most advanced program, Young Actors' Professional Intensive (YAPI) a 6-week intensive training program for teens. In fiscal year 2012, 1075 students participated in Studio East Summer Programs.**4c** (Code: 44-8000) (Expenses \$ 326,046. including grants of \$ 8,714.) (Revenue \$ 332,215.)StoryBook Theater (SBT): An adult professional touring company that presents original musicals for very young audiences - ages 3 through 10 - and their families. The mission of SBT is to introduce young children to the joy and magic of live theater. During fiscal year 2012, SBT presented 144 performances in Kirkland, Renton, Seattle, Everett, and Edmonds.
